The City of Winchester is divided into two Wards known as Ward I and Ward II. The dividing line between Ward I and Ward II shall be a line beginning at the intersection of the ► center line of Sulphur Springs Road and the eastern prolongation of the south rear property line of Hillcrest Boulevard; thence westwardly along the south rear property line of Hillcrest Boulevard to its intersection with the center line of Lindy Boulevard, thence northwardly along the center line of Lindy Boulevard to its intersection with the center line of Hillcrest Boulevard thence westward along the center line of Hillcrest Boulevard, to its intersection with the southern prolongation of the west rear property line of Lindy Boulevard, thence northwardly along said west rear property line to its intersection with the north rear property line of Hillcrest Boulevard, thence westwardly along said north rear property line to its intersection with the west city limits of the City of Winchester.

Ward I shall constitute all of the area with the boundaries of the City of Winchester that lies South of the above described line dividing Ward I and Ward II.

Ward II shall constitute all of the area within the boundaries of the City of Winchester that lies North of the above described line dividing Ward I and Ward II.

Effective 1989; provided additional protected classes. Title VIII means "<u>Don't</u> <u>Discriminate</u>." The Fair Housing Law prohibits discrimination in all housing regardless of ownership or management. Therefore, housing providers should <u>offer the same</u>, require the <u>same</u>, and inform all persons <u>regardless</u> of their race, color, sex, national origin, religion, familiar status (children under 18 years of age) or handicap. #### REMINDER TORNADO SIREN POLICY

To help the public prepare for tornado situations, a **TORNADO WATCH** and **TORNADO WARNING** program has been developed. A *tornado watch* means that conditions are favorable for tornado development. This is the time to prepare. You should keep alert by listening to radio, television or weather radio for the latest weather information. A *tornado warning* means a tornado has been sighted or indicated by radar. When a warning is issued, the sirens will be activated. It is important that local media sources or weather radio be monitored for the duration of the warning. The siren system does not sound an "All Clear" message so please listen to the National Weather Service for this information.

#### ENJOY MISSOURI STATE PARKS & HISTORIC SITES - WATKINS WOOLEN MILL STATE HISTORIC SITE AND BETHANY FARM (Northwest Missouri)

Established in 1839 as a small livestock farm in the northeast corner of Clay County, Mo. By 1870 Bethany had expanded into a 3,660-acre agricultural and industrial enterprise. The 1,240-acre home farm was surrounded by a number of smaller sections, including two 500-600 acre tenant farms. The plantation, as owner Waltus L. Watkins styled it, included an elegant home and a three-story mill where wool was spun into yarn, and woven into cloth, blankets and shawls. The plantation also had a brick kiln, a gristmill, sawmills, a blacksmith shop, a dairy, a fruit dry house, an icehouse, barns and other farm buildings, as well as a scale house, a wool shed and houses for the mill and farm workers. The Mount Vernon Church and octagonal Franklin Academy school building were built adjacent to the plantation.

Watkins, like most farmers of his day, practiced diversified farming. He raised shorthorn cattle, Missouri mules, horses, swine, sheep and poultry, grew various grain crops, and planted extensive orchards. He also marketed the services of his mills, kiln and blacksmith shop to people in the area. When the woolen industry reached Missouri in the 1850s, Watkins decided to take advantage of his early training in Kentucky textile mills and in 1860 constructed the Watkins Woolen Mill.

Watkins' nine children helped manage the family businesses. The boys assisted their father with the farm and mill operations, and Mary Ann and her four daughters oversaw the dairy, cared for the poultry flocks, and dried fruit for sale. They also maintained a large family garden, raised bees and sold the honey, and butchered up to 100 hogs each year and smoked the meat for sale. In 1868 Watkins went into partnership with his son John, forming the firm of W. L. Watkins & Son. After Watkins' death, three of his sons continued to operate the farm and mill as John H. Watkins & Bros.

The Watkins family lived at Bethany until 1945 when the farm and mill were sold. The mill and house were acquired by the Watkins Mill Association in 1958 and opened to the public. The property became part of the Missouri state park system in 1964. Watkins Woolen Mill was designated a *National Historic Landmark* in 1966, and was named a *National Mechanical Engineering Historic Landmark* in 1980. The mill and house, and the adjoining recreation area are administered by Missouri State Parks, a division of the Missouri Department of Natural Resources.

The City of Bethany is in northwestern Missouri and has a population of 3,292. It is located in Harrison County on Interstate 35 directly between Kansas City, Missouri and Des Moines, Iowa. Go to: www.mostateparks.com and search for Watkins Woolen Mill State Historic Site.

The historic site's Living History Farm Program operates weekly on Saturday and Sunday from Memorial Day weekend through early-August. Costumed interpretive staff present life in rural Missouri in the 1870s. Demonstrations focus on the way people lived and played in the 19th century. Tours of the woolen mill and Watkins house are offered daily. Please call the park office for details at 816-580-3387.

#### **SNOOPING IN THE TRASH**

The United States Supreme Court has ruled that once trash is placed near the curb for disposal, all expectation of privacy has been forfeited by the resident and anyone may legally examine the contents, including taking any items if they so desire. *In other words, it is legal for someone to go through your trash after you place it near the curb for disposal.* Therefore, police officials warn residents to be attentive to what they throw away (credit card statements, bank statements, other private information) so that they do not become a victim of identity theft.

### **CYBER BULLYING**

Being a victim of cyber bullying can be a common and hurtful experience. *The tips and resources below apply to everyone, not just children.* As with all transactions or sharing of information on the internet, use caution and be careful with what you share on-line.

- ☆ Watch what you say; if you wouldn't say it in person, DON'T say it on-line.
- Stay safe; keep personal information personal, share your phone number, address, etc. only with friends you've met face to face and trust.
  - Break the chain; passing along hurtful or unkind messages - even as a joke - is NEVER okay.
  - Don't take it; you can block offensive message senders, delete messages from unfamiliar addresses or report them to your electronic service provider.
  - Ask for help if you know cyber bullying is going on, talk about it with a trusted adult, parent, teacher or co-worker.

#### HOW MUCH SHOULD YOU CLEAN YOUR RECYCLABLES BEFORE DISCARDING IN THE RECYCLE BIN?

**Republic Services gives these guidelines:** 

#### **Rinse Jars, Bottles and Cans**

As a general rule, a quick rinse is more than adequate. You don't need to scrub the remains in the mayonnaise jar with soap before recycling, just fill the container with water and vigorously swish the water around inside. Better yet, use leftover dishwashing water just before you drain it! If the residue is sticky like jelly or honey, you may need to use a scrub brush or scraper to remove more of the product.

#### **Cardboard and Paper**

Note that grease and oil make cardboard and paper unrecyclable. Pizza boxes covered in grease aren't fit for the recycling bin. If the box is mostly clean with just a few specks of grease, you're fine to recycle it. The same goes for other contaminants. If you are making pancakes and a drop of egg lands on the box, it's still clean enough to recycle. Too much of a mess.....NO. Crumpled, torn or misshapen paper and cardboard can be recycled the sames as flat products. Paper that has been shredded or torn into bits shouldn't go into the outside bin as it can easily blow away and cause littering. In small quantities, it may need to be thrown away or at least (paper) bagged before being recycled. In large quantities, you can take it directly to any waste and recycling facility.

#### **Throw Away Heavily Soiled Items**

Unfortunately, some items cannot be recycled and should simply be thrown away. Any items that are heavily soiled or impossible to clean cannot be recycled. It is very important to sort your recycling correctly and make the process as simple as possible for your city. #### Bats and Wildlife Control Preventing Rabies in People and Pets

Saint Louis County Animal Care & Control is committed to keeping people and pets safe in Saint Louis County. With that said, we share this County with many native wildlife species. In general, wildlife found outdoors should be left alone. Animal Care & Control will respond to remove and test any wild mammal that has had contact with person or pet and could have transmitted rabies through a bite wound. Without the risk of rabies transmission, Animal Care & Control defers calls about wildlife outdoors—as well as in attic, crawl spaces, and other non-living quarters—to the Missouri Department of Conservation, Powder Valley at 314-301-1500 for wildlife control only. You can reach their office Monday-Friday from 10:00 a.m. until 6:00 p.m. at (314) 615-0650, select option #6.

Outside of these hours, our Officers can be routed to you by the County Police Department. Please call the police non-emergency line at (636) 529-8210 and ask for an Animal Control Officer to come to your location.

If no one in the house and no pets had contact with the wildlife, and you can safely do so, try to allow the wildlife the opportunity to leave on its own—open doors and windows, turn on lights, and don't stand between them and an exit.

If the bat or wildlife DID come into contact with a person or pet in the household, or if you are unsure, KEEP IT CONFINED—Animal Control will remove the wildlife and help you assess your level of risk for disease exposure. To confine a bat, turn all the lights on in the room-this can help to keep the bat from flying around. Keep an eye on its location, so that the Officers can quickly locate and capture it. The most common species of animals to carry rabies in the State of Missouri are bats and skunks. Bats are the species most commonly found to carry this disease in the Saint Louis Region. A very small number of bats come into contact with people or pets each year and require testing for rabies—less than 3% of those tested Statewide are actually carrying the disease. If you find a bat in your home, please call for an Animal Control Officer to remove the bat and help you assess if there was any risk of disease transmission.
