### NOTICE OF ELECTION DECLARATION OF CANDIDACY

CITY OF WINCHESTER



A **Municipal Election** will be held in the City of Winchester, St. Louis County, Missouri, on Tuesday, April 3, 2012, to elect *one Alderman from Ward I* and *one Alderman from Ward II*, each to serve a two (2) year term.

Declaration of Candidacy for said offices must be received by the City Clerk, Monday thru Friday, during regular business hours. Filing begins on Tuesday, December 13, 2011 at 8:00 a.m. The closing date will be at 5:00 p.m. on Tuesday, January 17, 2012.

A candidate must be a qualified voter properly registered under the laws and the Constitution of the State of Missouri. A Candidate must not be in arrears in any unpaid City of Winchester taxes and must have been a resident of the City of Winchester for at least one year preceding the election.

The City of Winchester is divided into two Wards known as Ward I and Ward II. The dividing line between Ward I and Ward II shall be a line beginning at the intersection of the center line of Sulphur Springs Road and the eastern prolongation of the south rear property line of Hillcrest Boulevard; thence westwardly along the south rear property line of Hillcrest Boulevard to its intersection with the center line of Lindy Boulevard, thence northwardly along the center line of Lindy Boulevard to its intersection with the center line of Hillcrest Boulevard thence westward along the center line of Hillcrest Boulevard, to its intersection with the southern prolongation of the west rear property line of Lindy Boulevard, thence northwardly along said west rear property line to its intersection with the north rear property line of Hillcrest Boulevard, thence westwardly along said north rear property line to its intersection with the west city limits of the City of Winchester.

Ward I shall constitute all of the area with the boundaries of the City of Winchester that lies South of the above described line dividing Ward I and Ward II.

Ward II shall constitute all of the area within the boundaries of the City of Winchester that lies North of the above described line dividing Ward I and Ward II.

**CITY MEETING NEWS**



In service to the community, your Board of Aldermen took the following action during **September, 2011:**

**ORDINANCES** - Your Board of Aldermen approved the following ordinances:

**#1004** - An ordinance authorizing the City of Winchester to enter into an agreement with Charter business for provision of telephone and internet services.

**#1005** - An ordinance establishing the annual rate of tax levy for the year 2011 on all property within the City of Winchester as follows:

Residential Real Estate	\$0.1980
Agricultural	\$0.0000
Commercial Real Estate	\$0.1720
Personal Property	\$0.2610



**NOTICE to all Winchester pet owners....** at the August 10<sup>th</sup> Board of Aldermen meeting it was **unanimously repealed the ordinance requiring City pet tags from the Municipal Code.** It remains, however, a county ordinance for both dogs and cats to be vaccinated against rabies. The veterinarian will issue a Rabies Identification Tag which should immediately be put on your pet's collar. An identifying microchip can also be injected under a pet's fur for a modest cost. This "chip" can be read with a special scanner even if your pet loses its collar and tag. These things could serve as your pet's "Free Phone Call Home". This is the responsible thing to do for your pet.

**REMINDER...**It shall be unlawful for the owner of **any dog or cat**, whether vaccinated or not, to permit such dog or cat to run at large or to go off the premises of the owner unless such dog or cat is under restraint. "At large" and "restraint" applies to cats as well as dogs.

*Municipal Code Section 205.190*

Winchester residents are limited to the number of pets they may have - no more than two dogs and no more than two cats.

### 2<sup>ND</sup> COMMUNITY CLEANUP

#### A SUCCESS!

The City of Winchester, in conjunction with the St. Louis County Public Works Problem Properties Unit and the St. Louis County Police, sponsored a free bulk pickup on Saturday, October 1<sup>st</sup>. The Mayor and Board of Aldermen wish to extend their thanks to all of the elected officials and employees of those agencies who volunteered to participate. The St. Louis County Police brought a group of Explorers to help as well. *A very special Thank You goes to the following friends and residents* that donated their trucks and time, some for the second time, to help: Angelo Deluca, Orville Grah, Tom Guy, Paul Hann, Jackie Johnson, Stephanie Keane, Carol Kraft, Wayne Kresyman, Greg Lewis, Martin Taveras and Ed Winston.

The pick up work began at 8:00 a.m. and finished about 1:00 p.m. Approximately 160 homes participated in the cleanup. One 30-yd and six 40-yd dumpsters were filled with bulky waste. Eight tons of scrap metal and eWaste were collected as well as 73 tires. The City will consider additional cleanups in the future. Let us know if you have any suggestions or comments regarding the Clean Up.

RNA Worldwide in Arnold, a company that participated in the community cleanup, offers FREE PICK UP services for computers, electronics, appliances and scrap metal recycling throughout the year.

Their office number is 314-338-6048. RNA is registered with the Missouri Department of Natural Resources, and strictly abides by EPA guidelines which is extremely important for the proper disposal of hazardous materials. They will pick up anything with metal in it, batteries, car parts, etc., and are often working in this area.

#### **BALLFIELD RESERVATIONS -**

Reber Park's two ballfields are available for Organized League Team Practice from *April 1<sup>st</sup>...or when the fields are deemed usable by City Hall...until the first week of June each year*. Ballfield Reservation Forms will be available at City Hall beginning **Tuesday, January 3<sup>rd</sup>**. Forms ***must be returned by mail via the US Postal Service*** to City Hall and will be processed on a first received, first served basis. Beginning January 9, 2012 walk-in applications will be accepted for the remaining time slots on a first come, first served basis, depending on field availability.

In order to recoup certain expenses, it has been determined that each athletic team using the ballfields in Reber Park will be required to pay a one time per season user fee of \$50.00 as partial recoupment.

Each team is limited to ***one practice session each week***. Practice sessions are two hours and are available:

**Cold Weather Tips**

**Check daily** on elderly friends, relatives and neighbors who live alone.

**The elderly and very young should stay indoors** as much as possible. Offer to shop for elderly friends and relatives. Just like in the summer with heat, it takes some time to get acclimated to cold weather.

**Wear layered clothing outdoors** for better protection from the cold. Wear a cap to prevent rapid heat loss from an uncovered head. Cover exposed skin to prevent frostbite.

**While indoors, try to keep at least one room heated to 70 degrees.** This is especially important for the elderly and small children to prevent hypothermia.

**Avoid drinking alcoholic beverages.**

**Eat high energy foods** along with warm beverages and soup.

**Sleep warm with extra blankets,** a warm cap, socks and layered clothing.

**Avoid fatigue and exhaustion** during cold weather. Overexertion, such as shoveling snow or pushing a car, can strain your heart.

**Carry extra clothing, blankets and high energy snacks,** such as cereal or candy bars in your car for protection if car stalls. Keep the gas tank near full to prevent icing. Don't travel alone.

**Be careful when using fireplaces,** stoves or space heaters to stay warm. Carbon monoxide poisoning and home fires are very real winter hazards. For answers to any questions about using space heaters or any other heating method to stay warm, please call your local fire department.

#### Tips for Proper Disposal of Pharmaceuticals

**Do not flush medicines!** This practice can harm the beneficial bacteria that break down waste in septic systems and wastewater treatment plants. Also, municipal wastewater treatment facilities are not designed to remove all the ingredients from the medicines in the treatment process. Untreated or partially treated pharmaceuticals are then released into nearby lakes, rivers or groundwater.

#### **Suggested tips for proper disposal:**

- ☒ Solid Medications should be removed from the original container and the contents put into a hard plastic container such as a laundry

detergent bottle. Add a small amount of water to dissolve the medicine. Add a thickening material such as cat litter, flour, or coffee grounds. Recap and seal the container with duct tape. Place it in the trash just prior to pick-up.

- ☒ Liquids should also be put into a hard plastic container, a thickening material added, the container recapped and sealed with duct tape, then placed in the trash just prior to pick-up.
- ☒ Foil-wrapped pill containers and patches should be kept in their original packaging, wrapped with a thick tape such as duct tape and put into a hard plastic container. Seal the container and place in trash just prior to pick-up.



### WINTER WEATHER PARKING - A

**Snow Emergency** goes into effect between the hours of **6:00 a.m. and 11:00 p.m. when an accumulation of snow and/or ice of two or more inches** is on the street. What does this mean? In Winchester, it basically means that there is no parking on the fire hydrant side of each street. This allows the snow removal crews adequate room for removing the snow and placing the salt/calcium chloride down on the roadways.

During a Snow Emergency there is **NO PARKING** on the following streets:

- North side of street East of Lindy  
Lakeside, Ballwin, Orchard, Hillcrest, and St. Lawrence
- West side of Chamberlin
- West side of Rosedale
- West of Lindy  
North side of Evergreen, St. Lawrence  
South side of James, Hillcrest  
East side of Fairview, Lindy south of Hillcrest
- West side of Solley
