PARK & RECREATION NEWS

All municipal parks in the City of Winchester shall be *closed between the hours of Dusk and 7:00 AM* and a person shall not be in the parks during those hours except as authorized by Pavilion permit.

The City is sorry to have to announce that the annual "Party in the Park" has been cancelled this year due to low participation the past several years. It has not yet been decided when or if it will be resumed. We do, however, hope that all the residents find ways to enjoy **REBER PARK!** Use the playgrounds or picnic at one of the tables installed around the park.

Reserve the pavilion and gazebo for parties and family gatherings. Reservations can be made by both residents and non-residents alike, **April through October** of each year, 7AM - 8:00 PM. Reservations are being taken at City Hall. First come - first served. A non-refundable fee of \$45 for the pavilion and a \$30 fee for the gazebo will be required for each date that is reserved.



REBER PARK- As residents are aware, the City attempts to keep the park clean and safe and hopes that it will be an asset in the lives of both

children and adults. During the summer months acts of vandalism are more likely to occur. The City is once again asking for your vigilance, especially those of you living close to the park. If you see any suspicious

FIREWORKS

Chapter 810 of the St. Louis County Code governing fireworks states that it shall be unlawful for any person, firm or corporation to sell, possess, offer for sale, expose for sale, give, use, discharge or explode fireworks within St. Louis County. *In other words, it is illegal to possess fireworks in St. Louis County.*

Safety Tips for Citizens

Below are some tips that may help you prevent crime. But remember—the most important single act you can do is to call the Police to report crimes or suspicious activities! If law enforcement is not aware of problems, they cannot resolve them. Here are some tips for homeowners to use so that they can help the anti-crime effort.

Install good deadbolt locks and use them.

Use timers to turn lights on and off in a normal schedule when away from home.

Adequately secure all windows with secondary locking devices.

Lock any non-attached structures to ward off theft. Leave exterior lights on at night.

Do not advertise that you are away from home.

Record serial numbers and maintain a record of your property in a safe place, preferably other than your home.

Call Police Dispatch at 636-529-8210 to report burglaries, thefts, vandalism, prowlers or suspicious activities. Use 911 for all emergencies.

SEWERS/CATCH BASINS - The City requests your cooperation in helping to maintain our sewers and catch basins as well as our streets. Please dispose of waste correctly. Improper disposal of any waste in the sewers and catch basins can cause unnecessary damage and expensive repairs. Being watchful in keeping grass clippings, pine cones, sweet gum balls, mud, leaves or other debris on the streets from entering the sewer/catch basins will help to save your tax dollars. Also, residue from the washing, repairing, or changing lubricants and other fluids in your motor vehicles should not be left in any roadway within the city. Please dispose of debris properly.

REMINDERS



City of Winchester Curfew for Children Children under 17 shall not loiter, idle, stroll, drive or ride in an automobile or

play in or upon public streets, highways, roads, alleys, parks, play grounds or other public place buildings, places of amusement and entertainment, vacant lots or other unsupervised places between 11:00 p.m. and 6:00 a.m. on Friday and Saturday nights or between 10:00 p.m. and 6:00 a.m. on other nights of the week.

A parent, guardian or other adult having the care and custody of a child under 17, shall not permit a child to violate the city curfew regulations. There are fines for such violations and juveniles may be taken into custody and transported to St. Louis County Juvenile Authorities. Please report any curfew violations witnessed to the St. Louis County Police Department at 636-529-8210.

The City of Winchester has a LEASH LAW - Neither dogs nor cats are permitted to run at large. Any pet must be on a leash, in an enclosed area, or properly restrained.

For the safety and enjoyment of all Winchester residents, City Hall encourages dog and cat owners to be responsible and leash or confine pets whenever outside.

(Municipal Code Section 205.190)

UNNECESSARY NOISE

City Hall receives complaints about people not being responsible for making sure that when their dogs are outside, they not be allowed to continuously bark and thereby disturb the public peace. Dogs are not the only problem, people cutting grass, loud music, operation of any unmuffled motor vehicle or causing screeching of tires, yelling, shouting, etc. all are unnecessary noises and if a complaint is made, the offender is subject to penalty, particularly between the hours of 11 P.M. and 7 A.M.

Grass Cycling - "Mulch" Easier than Bagging

A healthy lawn and grass cycling go hand in hand! Do your back and your lawn a favor and kick the bagging habit!

Grass clippings are a valuable source of nitrogen-rich organic matter. When mowing, remove no more than one-third of the total plant height so that the clippings are small enough to sift back down into the turf and break down quickly, thus returning valuable nutrients back to the soil. Using a mulching lawn mower or simply converting your existing mower with a mulching attachment is an easy way to practice grass cycling.

Mulching your grass clippings does not cause thatch! Thatch is a layer of living and dead organic matter that occurs between the green matter and the soil surface. It is actually the tough fibrous part of the grass stem (which takes much longer to decompose) that contributes to thatch buildup. However, clippings are very high in water content and break down rapidly when returned to the lawn after mowing (assuming the lawn is mowed regularly and that no more than one-third of the leaf blade is being removed during mowing).

Prepare, Plan and Stay Informed (condensed from the website www.ready.gov)

Often times we may not realize that our actions online might put us, our families and even our country at risk. Learning about the dangers online and taking action to protect ourselves is the first step in making the Internet a safer place for everyone. Cybersecurity is a shared responsibility and we each have a role to play.

Cybersecurity involves preventing, detecting, and responding to cyber incidents. Unlike physical threats that prompt immediate action, cyber threats are often difficult to identify and comprehend. Among these dangers are viruses erasing entire computer systems, intruders breaking into computer systems and altering files, intruders using your computer or device to harm others, or intruders stealing confidential information.

You can increase your chances of avoiding cyber risks by setting up the proper controls, for example:

- ✓ Only connect to the Internet over secure, password-protected networks.
- ✓ Do not click on links or pop-ups, open attachments or respond to emails from strangers.
- ✓ Always enter a URL by hand instead of following links if you are unsure of the sender
- ✓ Do not respond to online requests for Personally Identifiable Information (PII); most organizations banks, universities, companies, etc. do not ask for your personal information over the Internet.
- ✓ Limit who you are sharing information with by reviewing the privacy settings on your social media accounts.

Your personal information includes, but is not limited to:

Full Name, Social Security Number, Address, Date of Birth, Place of Birth, Driver's License Number, Vehicle Registration Plate Number, Credit Card Numbers, Physical Appearance, Gender or Race....

If you believe your PII is compromised:

- ✓ Immediately change all passwords; financial passwords first. If you used the same password for multiple resources, make sure to change it for each account and do not use that password in the future
- ✓ If you believe the compromise was caused by malicious code, disconnect your computer from the Internet.
- ✓ Contact companies, including banks, where you have accounts as well as credit reporting companies.
- Close any accounts that may have been compromised. Watch for any unexplainable or unauthorized charges to your accounts.
- ✓ File a report with the local police so there is an official record of the incident.

If your PII was compromised, consider other information that may be at risk. Depending on what information was stolen, you may need to contact other agencies for example, if someone has gained access to your Social Security Number, contact the Social Security Administration. You should also contact the Department of Motor Vehicles if your driver's license or car registration has been stolen.
