A Municipal Election will be held in the City of Winchester, St. Louis County, Missouri, on Tuesday, April 8, 2014, to elect one Alderman from Ward I and one Alderman from Ward II, each to serve a two (2) year term.

A candidate must be a qualified voter properly registered under the laws of the Constitution of the State of Missouri. A Candidate must not be in arrears in any unpaid City of Winchester taxes and must have been a resident of the City of Winchester for at least one year preceding the election.

The City of Winchester is divided into two Wards known as Ward I and Ward II. The dividing line between Ward I and Ward II shall be a line beginning at the intersection of the center line of Sulphur Springs Road and the eastern prolongation of the south rear property line of Hillcrest Boulevard; thence westwardly along the south rear property line of Hillcrest Boulevard to its intersection with the center line of Lindy Boulevard, thence northwardly along the center line of Lindy Boulevard to its intersection with (Continued)

CITY MEETING NEWS



In service to the community, your Board of Aldermen took the following action during November/ December, 2013:

ORDINANCE

#1026 - An Ordinance authorizing the City of Winchester to enter into a contract with Cintas Document Management to ensure the safe disposal of outdated City records.

#1027 - An Ordinance providing for the execution of a contract between the City of Winchester and the St. Louis County Police for full time police service within the City of Winchester, Missouri, and providing for payment thereof.

TAX FORMS - For several years, because of the continued growth in electronic filing and the availability of free options to taxpayers, individual and business taxpayers no longer receive paper income tax packages in the mail from the IRS. Federal Income Tax Forms and Publications can be found at the <u>www.irs.gov</u>. The State of Missouri *will not be supplying* individual tax forms. You can obtain tax forms by visiting the MoDOR website at: <u>www.dor.mo.gov/tax</u>. Both of the previously mentioned website's forms are "Fill-in". In other words, you can fill them out on line and print them. You may obtain forms by using the automated Fax-on-Demand system (Form by Fax) at 573-751-4800.





WINCHESTER NEIGHBORHOOD STATION SAFETY TIPS

If your home is broken into:

If a door or window has been forced or broken while your were away, DO NOT enter or call out! Someone may still be inside. Use a cell phone or neighbor's phone immediately to call the police and wait there until they arrive.

When you call the police:

Try to remain calm.

Use 911 for medical emergencies, fires and crimes in progress. Someone should respond within a few minutes on a call of this type. In many situations, an officer may be dispatched while you are still providing information to the Communications Specialist.

Call Dispatch at 314-889-2341 or 636-527-2341 to report burglaries, thefts, vandalism, prowlers or suspicious or disruptive activities. *You will be ask to provide:*

Your name, address and phone number

What happed? Describe as briefly as possible. When Did it Happen? Tell if the crime is in progress or when it occurred.

Who did it? Name or describe the suspect or vehicle, if there is one.

<u>Where Did They Go?</u> Which way and how did they leave?

Wait for the officer to arrive or to return your call. The time it takes for an officer to arrive will depend on many factors. The officer may ask you questions similar to those asked earlier. Please be patient.

In many situations it may be unnecessary for an officer to come to you. Nearly 15% of all police cases are handled over the telephone. Keep track of the case number you are given by the officer. It will be needed by your insurance company if you file a claim. All future police activity related to that event will be linked to that number. If there is enough information, the case will be passed on to a follow-up detective. It will be a few days before you are contacted. If you have new information to give to the detective, be sure to reference your case number.

Putting a recycling "bin" in several places in your home will help you recycle everything you possibly can. Don't forget the laundry area! When single stream recycling, all of the recyclables go into the same container. When recycling, labels and lids are okay! Give items a quick rinse to keep your bin clean.

Here is an extensive list of recyclables:

Plastic - Recycle all plastic containers such as plastic tubs, screw-top jars, jugs, cups, all types of bottles. The ONLY exception to the plastic container rule is polystyrene or Styrofoam. Styrofoam cannot yet be recycled at the curb.

Paper - All sorts of paper can be recycled.

Metal - recycle all aluminum bottles, foil, pans and cans. All steel/tin cans, such as soup cans, are recyclable.

Glass - Recycle all of your glass jars and bottles.

Cardboard & Paperboard - Any size box can be recycled curbside. Break down boxes to make room inside your recycling cart for other recyclables.

What NOT to Recycle:

NO plastic bags can be recycled at home. You can take them to a grocery store to be recycled. **NO** plastic wrap, food wrappers, sandwich baggies or bread bags - if it is not a container, do not recycle it.

NO tissues, paper towels or napkins may be recycled.

NO scrap metal may be recycled curbside.

NO drinking glasses, window glass, mirror glass or Pyrex glass may be recycled.

PARK & RECREATION NEWS

BALLFIELD RESERVATIONS -

Reber Park's two ballfields are available for Organized League Team Practice from April 1st, or when the

fields are deemed usable by the City, until the end of June each year.

Ballfield Reservation Forms are available at City Hall at 9:00 a.m. on Jan. 2, 2014. Applications will be processed on a first come, first served basis, depending on field availability. Teams are required to pay a per season user fee of \$50.00. Each team is limited to one practice session each week. Practices sessions are two hours and are available:

Health Department Urges All Residents To Get Vaccinated Against Seasonal Flu

Flu season has arrived and the Saint Louis County Department of Health is urging all residents six months of age and older be vaccinated against the seasonal flu. Even those who aren't worried about catching the flu should be vaccinated.

"For many, flu is just an inconvenience, but for some it can be life threatening," said Dr. Dolores J. Gunn, director of the health department. "Getting vaccinated is not just about protecting yourself. It's also about protecting others. If you don't catch the flu, then you can't spread the flu."

This year's seasonal flu vaccine offers protection against several different strains of flu based on recommendations from experts around the world who determine each year which types are most likely to be circulating in the fall.

To find out where to go for seasonal flu vaccinations, residents are encouraged to visit the Saint Louis County Department of Health's flu website: www.SaintLouisCountyFlu.com

Depending on the severity of the outbreak, between 15 and 60 million Americans are infected by seasonal flu each flu season. Over 200,000 people are hospitalized every year due to flu-related complications and around 36,000 of them die.

Other standard precautions being urged by the county health department are:

- Wash your hands frequently with soap and water.
- Cough and sneeze into a tissue or into your sleeve.
- Avoid touching your eyes, nose, or mouth.
- Try to maintain a distance of three feet between you and others.
- Stay home when you are sick or think you may be getting sick.

REMINDER

The City of Winchester has a LEASH LAW - Neither dogs nor cats are permitted to run at large. Any pet must be on a leash, in an enclosed area, or properly restrained.

For the safety and enjoyment of all Winchester residents, City Hall encourages dog and cat owners to be responsible and leash or confine pets whenever outside.

Pet waste can provide food for rodents. It also comes into contact with storm water which carries pollutants into the storm sewer system and cause viruses and parasites that can infect humans with dangerous pathogens such as salmonella. Studies by the EPA have found that bacteria levels are often elevated 100% after a rain. One way to reduce that level is to clean up after your pets.

Remember, residents who walk their pets must be responsible and prepared to clean up after their animals on any city property. Not doing so is a violation of Municipal Code.


LAFAYETTE OLDER ADULT PROGRAM (L.O.A.P.)

Section 365.120 and a traffic ticket will be issued.

Zoning code Section 405.135 enacted in 2007 pertains to **Temporary Storage Units, or PODS**. In general, the user must obtain a no-fee permit. Only one POD shall be allowed for a dwelling at any one time; placed either in the driveway or in an approved paved, parking area and not within any public right-of-way, including sidewalks; be no greater than 1,100 cubic feet in size; placed on the property for a period not to exceed fourteen (14) calendar days, unless approved by the Code Enforcement Officer of up to a maximum of twenty-eight(28) days in a given calendar year.



The following information is presented from the stormwater library of the Phase II Stormwater Management Plan which has been initiated by the Federal Government through the EPA.

ILLEGAL DUMPING AND LITTERING

Illegal dumping is the disposal of waste generated at one location and disposed of at another location without legal permission. Illegal dumping is the disposal of trash, tires, yard waste, appliances and other waste materials disposed of *on both private and public property* without permission of the property owner.

People illegally dump in unsecured vacant lots, remote spaces, roadways, parking lots, abandoned buildings, poorly lit areas and waterways, including creeks, drainage swales, rivers and dry weather ditches.

This disrespect for other's property and the environment can cause health hazards including: physical injuries from sharp and pointed objects, diseases from rodents and insects, fires from flammable materials, flooding from material blocking flood control channels and storm drains. Economic concerns include: decrease in property values and the expense to clean up the pollutant loads in our storm water facilities.

They offer FREE PICK UP services for computers, electronics, appliances and scrap metal recycling throughout the year. Their office number is 314-338-6048. RNA is registered with the Missouri Department of Natural Resources, and strictly abides by EPA guidelines which is extremely important for the proper disposal of hazardous materials. They will pick up anything with metal in it, batteries, car parts, etc., and are often working in this area.
