Chapter 810 of the St. Louis County Code governing fireworks states that it shall be unlawful for any person, firm or corporation to sell, possess, offer for sale, expose for sale, give, use, discharge or explode fireworks within St. Louis County. In other words, it is illegal to possess fireworks in St. Louis County.

Fireworks are very dangerous in the hands of an untrained person. Instead of putting you or your family and friends in jeopardy, we suggest you attend one of the local firework displays. Check your local news or newspapers for a location near you.

A "tale of two storms"

During heavy storms, like the those commonly experienced in the St. Louis area during throughout Spring, too much water entering our stormwater system can "overcharge" the sewer mains, meaning that untreated wastewater can sometimes back up into residential or commercial basements. In April 2013 and again in April 2014, rainstorms blew through the St. Louis area, but the storms had very different impacts on our community. After the 2014 events, basement backups from overcharged mains were **reduced by 64%**, **saving \$250,000** in basement backup claims, all thanks to repair, maintenance, and system improvement efforts that are part of MSD Project Clear. Using a three-pronged approach, MSD Project Clear's goals are to improve water quality and to alleviate many wastewater concerns in the St. Louis region.

Since the launch of the program, MSD Project Clear has continued an extensive program of sewer rehabilitation, lining and maintenance throughout the District that has resulted in significant reduction in basement backups. In addition, Project Clear installed the first storage tank of the program in the Coldwater Creek watershed. During the April 2014 storm, the installation of the Coldwater Creek Storage Tank stored between 8 and 10 million gallons of untreated This tank, and other future scheduled wastewater. improvements, negates the need to build an additional 5 miles of wastewater sewers – a cost savings of nearly \$70 million. The tank does this by storing additional wastewater at peak flow times. Projects like this storage tank have resulted in significant reductions in system overcharges throughout the District.

MSD Project Clear is the Metropolitan St. Louis Sewer District's initiative to improve water quality and alleviate many wastewater concerns in the St. Louis region. MSD Project Clear will invest billions of dollars over a generation in planning, designing, and building community rainscaping and system improvements, along with an ambitious program of maintenance and repair and the disconnection of some residential downspouts in parts of St. Louis County's separate sewer area from the wastewater sewer line. This work is part of an agreement between MSD and the United States Environmental Protection Agency.

SOLICITATION- NO VISIT LIST

It's been a number of years since the "No Visit List" has been updated. Many residents have come and gone and *a new list will be replacing the original*. In compliance with the City of Winchester Municipal Code, Chapter 610, residents of the City are entitled to be registered at City Hall on a "no visit" list to try to eliminate unwelcome visitations as much as possible.

One of the most frequent calls for service the police department receives is on complaints regarding solicitors or peddlers. Any individual or group wishing to sell products or services in the City must first obtain a permit from City Hall. Once the permit is issued, solicitors must abide by certain regulations set forth by ordinance. The City has limited ability to prohibit peddlers or solicitors from their commercial or charitable activities due to First Amendment protections. There are a few things that you can do to help yourself:

- Post a "No Soliciting" sign. The City Hall has "No Solicitors" labels for your use.
- Contact us by phone or by clipping, completing and returning the form on the back of this newsletter. Any itinerant merchant registering with city hall will be given your <u>address only</u>.
- The issuance of a City Permit is NOT AN ENDORSEMENT!
- Do not allow the solicitor inside of your residence, give out personal information, date of birth, social security number, etc.
- Be aware that one solicitor may try to distract you while another commits a crime.
- If you feel uncomfortable talking with a solicitor, ask them to leave.
- Do not feel obligated to purchase any product or service.
- Remember, if a deal sounds too good to be true, it probably is.
- If you contact the police, *try to have specific information* about the person(s) and any vehicle(s) that you observe.....

Please note that this list is going to be completely new. You will not be on the "No Visit" list unless you respond to this questionnaire. Any itinerant merchant registering with city hall will be given a list of addresses only.

REMINDERS



City of Winchester Curfew for Children under 17 -Children under 17 shall not loiter, idle, stroll, drive or ride in an

automobile or play in or upon public streets, highways, roads, alleys, parks, play grounds or other public place buildings, places of amusement and entertainment, vacant lots or other unsupervised places between 11:00 p.m. and 6:00 a.m. on Friday and Saturday nights or between 10:00 p.m. and 6:00 a.m. on other nights of the week.

A parent, guardian or other adult having the care and custody of a child under 17, shall not permit a child to violate the city curfew regulations. Fines for such violation range up to \$500.00 and juveniles may be taken into custody and transported to St. Louis County Juvenile Authorities. Please report any curfew violations witnessed to the St. Louis County Police Department at 636-527-2341.



The City of Winchester has a LEASH LAW-Neither dogs nor cats are permitted to run at large. Any pet must be on a leash, in an enclosed area, or properly restrained.

For the safety and enjoyment of all Winchester residents, City Hall encourages dog and cat owners to be responsible and leash or confine pets whenever outside.

YES!, CARTONS ARE RECYCLABLE!: Now the last drop of milk, juice or soup does not mark the end of a carton's useful life. Cartons are easy to recycle and in high demand. Simply place empty cartons in your recycling bin with your plastic, metal and glass containers. Bales of recycled cartons are shipped to paper mills where cartons are mixed with water in a gigantic blender to extract all the paper fiber. Paper fibers are included in cardboard, newspapers, magazines, junk mail, phone books, office paper and folders. These recycled carton paper fibers are valuable resource for making products such as recycled paper products and even building materials.

PLASTIC BAGS 101 - Why can't they be recycled curbside, even if they have a recycling symbol on them? Plastic bags are the most common contaminant and, if missed, end up wound around equipment, resulting in a system shutdown. Plastic grocery bags can be recycled at most grocery stores. Look for the drop-off container at the front of the store. If you need a liner in your recycling bin or to contain shredded paper, please use a paper bag - paper bags are 100% recyclable!
