The City of Winchester is divided into two Wards known as Ward I and Ward II. The dividing line between Ward I and Ward II shall be a line beginning at the intersection of the center line of Sulphur Springs Road and the eastern prolongation of the south rear property line of Hillcrest Boulevard; thence westwardly along the south rear property line of Hillcrest Boulevard to its intersection with the center line of Lindy Boulevard, thence northwardly along the center line of Lindy Boulevard to its intersection with the center line of Hillcrest Boulevard thence westward along the center line of Hillcrest Boulevard, to its intersection with the southern prolongation of the west rear property line of Lindy Boulevard, thence northwardly along said west rear property line to its intersection with the north rear property line of Hillcrest Boulevard, thence westwardly along said north rear property line to its intersection with the west city limits of the City of Winchester.

Ward I shall constitute all of the area with the boundaries of the City of Winchester that lies South of the above described line dividing Ward I and Ward II.

Ward II shall constitute all of the area within the boundaries of the City of Winchester that lies North of the above described line dividing Ward I and Ward II.

**REMINDER** - *Bulky items* are defined

as household materials that are too large to fit in with your regular waste collection container and that are not bundled into 4-ft or less bundles. Examples of bulky items are furniture, carpet, old bicycles, and some household construction materials. Wood, drywall etc. is limited to (1)-32gallon can per pickup. (Carpet must be bundled 4ft x 2ft or less). Containers may weigh no more than 50 lbs.

In addition, Republic Services still picks up "white goods" - appliances, etc. Winchester residents can call for appliance pickup which would include TVs and microwaves as well as refrigerators, stoves, etc., but there is a charge of \$25 per item for the service. The pickup day will most likely not be on a Thursday, the regular trash, yard waste and recycle pickup day. Call 636-947-5959 to schedule a pickup.

**SLIDING GLASS DOORS AND WINDOWS**

Below are some tips that may help you prevent crime. But remember—the most important single act you can do is to call the Police to report crimes or suspicious activities! If law enforcement is not aware of problems, they cannot resolve them. Here are some tips for homeowners to use so that they can help the anti-crime effort.

Sliding glass doors present a major security problem if they do not have the proper locks and special steps are not taken to prevent removal of the door. Sliding glass doors can be lifted from the track and removed by pushing in the bottom of the door. To prevent the doorframe from being opened in this manner it is recommended that 1-1/4" pan head sheet metal screws be inserted into the top of the door frame at both ends and in the middle. The screws should be adjusted so that the door barely clears them when it is operated.

Once screws are in place, to prevent the door from being lifted while it is closed, lock the door handle and place a wooden dowel or metal rod in the floor track. This should make your sliding glass door secure. *For additional security*, a safety film for glass is available. The film is applied to the glass and if the window is ever shattered, the film holds the glass together making entry difficult if not impossible. Call Dispatch at 636-529-8210 to report burglaries, thefts, vandalism, prowlers or suspicious activities.

### CONSUMER RULES TO AVOID SCAMS, DISPUTES and UNEXPECTED COSTS

#### # 1

Never give out your personal information to anyone who contacts you. Only release the information when you initiate the contact. Only then do you know exactly who you are dealing with.

#### # 2

Don't pay full price up front if you haven't received the product or service. If a contractor or service provider needs money in advance, pay no more than 25 percent.

#### # 3

Work with companies that are known or recommended by someone you trust. Check a company's reputation with your local Better Business Bureau or the Attorney General's Consumer Protection Hotline at 800-392-8222. Also, check online for consumer complaints with the KnowMo database at [ago.mo.gov](http://ago.mo.gov).

#### # 4

Never make a financial decision under pressure. No matter what the salesperson says, you'll be better off if you take time to think about it, ask around and compare options.

### Recycling Frequently Asked Questions

#### Q 1. Why can't I recycle Styrofoam curbside?

A. It currently is not economical to pull polystyrene, or Styrofoam, from the single-stream sorting process. Processors that re-manufacture recycled Styrofoam are not located near St. Louis County. Styrofoam is 95% air and cost-effective transportation requires compressing the air out to turn large volumes of material into one very dense “log” for shipping. Drop-off locations are available for clean Styrofoam to be collected through partnerships with

businesses who own densification equipment. Styrofoam can be taken to Foam Products Corporation (FPC), 2525 Adie Rd., St. Louis, MO 63043. FPC will take clean Styrofoam from packing materials only at no cost. No food clamshells of any kind will be accepted. Styrofoam must be boxed or bagged for drop off. Progress is being made, especially in the commercial sector, but residential curbside recycling of Styrofoam is not economically viable at this time.

#### Q 2. Why can't I recycle plastic bags?

A. Some plastic bags are recyclable (such as grocery and box store bags), but **not** through the curbside program. Please return recyclable bags to the store. Plastic bags in curbside programs *cause major problems* for the sorting process! Recyclables are separated utilizing mainly automated systems, the plastic bags can end up wrapping around the equipment. When this happens, the system has to be shut down and the bags cut out.

#### Q 3. Does it really get recycled?

A. Yes, there are three processors in St. Louis County and one in St. Louis City. The industry is highly automated with many technologies to sort out all of the materials you put into your cart. It is more cost effective for a waste hauler to drop off recycling rather than sent it as trash to the landfill. You can rest assured that the recyclables you collect are indeed being sent to a recycling facility, creating local jobs and diverting valuable resources. With that being said, if you witness a waste hauler dump your recycling into the same truck at the same time with your trash, please contact St. Louis County Solid Waste Program Enforcement at [waste.doh@stlouisco.com](mailto:waste.doh@stlouisco.com) If verified, the hauler is in violation of the Waste Management Code.

**Q 4. Do I have to wash my recyclables? How clean do they need to be?**

- A. No, it's not necessary to wash your recyclables in the dishwasher or by hand. To keep your recycling container clean, it is helpful for materials to be relatively clean and dry. For residue such as ketchup or peanut butter, a spatula is simpler and easier to use than rinsing. Please dump out any leftover liquids.

**Q 5. What happens to the stuff that can't be recycled?**

- A. Material that is not recyclable is pulled out by hand or sorted out through automation. These materials are called "residual" and are sent to the landfill.

**Reminder: Your toilet is not a trash can!**

Cleaning and disinfecting wipes, personal hygiene products, baby wipes... they all are "disposable", so why not flush them down the toilet?

Quite simply, because disposing of such items in the toilet, even those labeled "flushable", instead of in the trash causes big problems, both for the Metropolitan St. Louis Sewer District and for homeowners.

Mounds of disposable materials clog sewer lines, pumps and lift stations. They can cause sewer backups and damage plant equipment. Clearing such materials from the wastewater stream is time-consuming and labor-intensive. Even dental floss flushed down the toilet can cause problems. Dental floss is very strong and durable. It can get tangled up in pumps and equipment, or worsen minor clogs within pipes by "binding" materials together.

These items are also a big problem for property owners' home plumbing and sewer laterals which are smaller in diameter and more susceptible to clogs. The sewer system is not designed for disposable wipes, dental floss, or similar items. Sewer clogs caused by these items can result in considerable cleanup expense and potential harm to our environment.

Please don't use your toilet as a trash can. Only human waste and toilet paper should be flushed down your toilet. Put everything else in the trash, where it belongs.

**Communicable Disease Control Services  
in St. Louis County**

People often take public health for granted in St. Louis County: our drinking water will not make us ill; our restaurants and supermarkets will not poison us; we and our children will not catch fatal diseases from neighbors or school friends. A thin shield, a fine web of public health practices and personal habits, protects us from the nasty, brutish and short life that has been the rule for so much of human history. Two important facets of the shield are *communicable disease control* and *health education*.

**St. Louis County CDC Services provide:** year-round immunization services for children and adults; special immunization services such as fall flu campaigns and other prevention campaigns as needed; general protection against a wide variety of communicable diseases; control of outbreaks, containment of effects, tracking down contacts to be sure they're treated and to be sure the community is safe; tuberculosis control services; sexually transmitted disease control services; refugee health program and travel shots.

Communicable disease fact sheets show how *your own acts* make your County's communicable disease shield weaker or stronger. Get proper immunizations for yourself and your family. This builds your own shield against the diseases of the past. Practice personal hygiene. Hand washing is an essential part of home and community hygiene, preventing the spread of a variety of diseases, including the common Hepatitis A!

Practice safe food preparation and storage-keep it hot or keep it cold. Help control diseases spread through rats, mosquitoes and flies by keeping tight-fitting lids on trash cans, not letting water stand in tires, ditches, buckets, etc. Be a responsible pet owner, picking up after, immunizing and spaying or neutering.

**FAIR HOUSING** - The City of Winchester is committed to Fair Housing for all of its citizens. **REBER PARK PAVILION & GAZEBO  
RESERVATIONS**

Reservations for the pavilion and gazebo were available the first business day in February. The facilities may be reserved individually and/or together. Hours are from 7a.m. - 8:00 p.m., April through October. These facilities are great for special functions, family reunions, barbeques, and birthday parties. Restrooms are specifically designated for the parties reserved. **Cost to reserve the pavilion is \$45, the gazebo, \$30.** Both residents and non-residents are eligible to reserve the facilities.
